

## **ST MARY'S CATHEDRAL CHOIR TOUR JUNE 2026 – FUNDRAISING ENDEAVOUR - RAFFLE TICKETS**

### **TERMS AND CONDITIONS:**

1. This raffle is organised by the Catholic Archdiocese of Sydney ABN 72 823 907 843 (**CAS**) for the St Mary's Cathedral Choir Tour in 2026, to give away 4 prizes of different values (**Prizes**).
2. Raffle tickets cost \$5 each (**Tickets**). Tickets are not tax-deductible.
3. The Prizes are valued as follows:
  - 1<sup>st</sup> Prize is valued at \$4,000 - weekend away for up to 4 people.
  - 2<sup>nd</sup> Prize is valued at \$2,000 – technology bundle.
  - 3<sup>rd</sup> Prize is valued at \$1,000 – dining experience for a family of up to 6 people.
  - 4<sup>th</sup> Prize is valued at \$500 – shopping voucher.
4. Prizes cannot be redeemed for cash.
5. Prizes will be drawn on Monday, 2 February 2026, at the Development and Fundraising Office, Catholic Archdiocese of Sydney, located at St Martha's, 38 Renwick Street, Leichhardt.
6. Winners will be notified by telephone and/or email by Friday, 6 February 2026.
7. Prizes can be collected from the Development and Fundraising Office, Catholic Archdiocese of Sydney, 38 Renwick Street, Leichhardt.
8. If a winning ticket is drawn and no person claims the prize by 5pm, Wednesday, 25<sup>th</sup> February, 2026, that ticket will be discarded and a second ticket drawn (with this process repeated until the particular prize is claimed).
